MOTION FROM MAY MEETING: Mara motions that every athlete in the top sideline and AA categories who score a 75% or higher qualify for state. From those athletes they are all eligible to complete the form, those athletes that then meet all qualifications are named to the All State team. This can be modified and reevaluated as needed by the board. Courtney seconds the motion. Motion carries.

Jen asks if we would like to continue at 75% for jump off as well or if we would like to look at other points options that qualify an athlete. Mara states to keep it 75% for consistency across the board. Dakia states that she prefers to have a solid score to obtain.

8:05 pm 12. *Coach Requirements - Head and Assistant and Board Lawson

Jen asks what the board's thoughts are on continuing on with the teams only requiring head coaches to be certified. Mara states that she is in agreement with this, but sees that if schools are not going to pay for all coaches to be covered then there may be issues raised with this. Audrey stated that for safety purposes we do need to make sure that all schools are in compliance with the safety rules. Missy asks if other sports require their assistant coaches to be certified for their sports. Audrey states that our rules and standards are much different than other sports. She states that our goal is to promote safety so we should be showing that as a board. Trent states that any coach with a student should be certified if they are going to be responsible for athletes.

Dakia motions that all cheer coaches in the state are certified under the NDCCA.

Mara asks if schools are willing to only pay for their head coach to be certified if teams could be allowed to stunt only when that coach is present. Audrey states that that is how we are operating currently and this is what we have hoped would be happening, but it has not been happening so this is going to be more clear on the rules in place. Jen suggests that coaches apply for more grants if their schools cannot pay for them. Missy suggests that we look at our grant dates to offer more than just in April. Missy brings the point of how it would negatively impact their schools and suggests we let Kevin propose it to the ADs as he has said he will. Jen asks if we would like to hold off for now. We will wait to make changes on this until after Kevin speaks to the ADs.
